Current Hourly Dues.....\$0.80

Roofers Union Local # 70 initiation (if applicable) \$5.00 per day

New Hires (no previous union hours) do not receive monthly vacation for the 1st 1000 hours

Pro Apprentices do not receive pension or insurance for the first 30 calendar days

Negotiated \$0.25 in HRA paid into Insurance fund to be allocated to individual member HRA accounts at Fringe Office

Pro Apprentices move to 1st class after 500 hours.Apprentices move to next class after 720 hours

Foreman large crew is a crew of 6 or more

Organizing is added to the base rate, taxed, then deducted

Vacation is added to the base rate, taxed, then deducted & paid on a monthly fringe report

Zone one is 0 to 50 miles from intersection of I96 & US23 in Brighton MI.Travel expense will be paid at \$16.00 per day except when working in Wayne, Oakland & Macomb counties in MI, then travel expense will be paid at \$2.00 an hour instead of \$16.00 per day

June 1, 2019 \$1.20 across the board (allocation to be determined by a vote of the members)
