Current Hourly Dues.....\$0.70

Roofers Union Local # 70 initiation (if applicable)...\$5.00 per day

New Hires (no previous union hours) do not receive monthly vacation for the 1st 1000 hours

Pro Apprentices move to 1st class after 500 hours-Apprentices move to next class after 720 hours

Pro Apprentices do not receive pension or insurance for the first 30 calendar days

If the increase in the hourly insurance contribution is more than an apprentice raise in any of the 3 years, the contractor will make up the difference with an additional hourly contribution which when added to the apprentices raise will not exceed \$0.50 total

Foremen large crew is 6 or more

Organizing is added to the base rate, taxed then deducted

Vacation is added to the base rate, taxed then deducted and paid on a monthly fringe report

Expires May 31, 2019
